Release and Indemnity Agreement

In consideration for my child's participation in Kids Nature Adventures, LLC (Kids Nature Adventures) I hereby stipulate and agree to the following:

Assumption of Risk

As a parent/guardian of a minor child participating in activities that involve nature exploration, hiking, climbing, running, jumping, playing, wading, and recreational activities such as tag, relay races, Frisbee, biking, kayaking, rock climbing, paddle boarding, fishing and other group or individual activities, I am fully aware that these activities entail known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to my child, to property, or to third parties. My child's participation in these activities may pose such danger as slips, falls, scrapes, twists and jolts, collisions, physical aggression from other campers or from insects and animals, impact with other children and other stationary or moving objects whether due to the negligence of Kids Nature Adventures or otherwise and that injuries and/or death may occur. I represent that my child does not have any medical, physical or emotional condition, which could hinder or prevent them from active participation in these activities in any way whatsoever.

I agree for myself, my child(ren) and any other guardian to assume full responsibility for my child's participation in any of these activities at Kids Nature Adventures and their potential for: slips and falls and falling, drowning, pinches, scrapes, twists and jolts that could result in scratches, bruises, lacerations, fractures, concussions, or even more severe life threatening hazards. During an activity there may be contact with plants, animals or insects that could create hazards such as stings, allergies, and associated diseases. I VOLUNTARILY AND FREELY CHOOSE TO ASSUME ALL SUCH RISKS AND DANGERS FOR MY CHILD, including the risk of injury or death that may be associated with, or result from, our participation in these outdoor activities, and transportation thereto, even if caused by the negligence of Kids Nature Adventures, its owners, employees, agents, or volunteer parents. I also assume any and all responsibility for my participation in any activities sponsored by or related to Kids Nature Adventures.
